**NOTICE PURSUANT TO LOCAL BANKRUPTCY RULE 202 OF  
TRUSTEE'S PENDING MOTIONS**

TO ALL PARTIES IN INTEREST:

NOTICE IS HEREBY GIVEN that Jeffrey A. Weinman, as Chapter 7 Trustee for the Adam Aircraft Industries, Inc. bankruptcy estate (the "Trustee"), has filed the following (the "Motions"):

**(a) Motion For Orders: (A) Authorizing and Scheduling an Auction to Solicit Bids for the Sale of Substantially all Assets of Debtor's Bankruptcy Estate, Free and Clear of Liens, Claims, Interests and Encumbrances; (B) Approving Bid and Auction Procedures; (C) Scheduling a Hearing to Consider Approval of the Sale; and (D) Establishing the Form and Manner of Notice;**

**(b) Motion to Establish Procedures for Determination of Cure Amounts and for Approval of Assumption and Assignment of Executory Contracts and Unexpired Leases Pursuant to an Auction Sale; and**

**(c) Motion for Limited Authority to Operate Business Pending Auction.**

The Trustee seeks in the Motions to establish auction and bidding procedures for the eventual sale of assets, procedures for determining cure amounts for executory contracts and unexpired leases, and limited authority to operate the Adam Aircraft Industries, Inc. business pending conclusion of the sale process. A copy of the Motions and any exhibits are available for inspection at the Bankruptcy Court or upon request from the undersigned attorney. The Trustee also has filed a motion seeking to shorten the notice period and limit notice for any objections to the Motions. Pursuant to Rule 202 of the Local Rules of Bankruptcy Procedure, if the Court grants the motion to shorten and limit notice, and if you desire to oppose any of the Motions, you must file a written objection and request for hearing with the Court on or before **March 6, 2008**, and serve a copy thereof on the undersigned attorney. If the Court denies the motion to shorten

and limit notice, you must file a written objection and request for hearing with the Court on or before **March 17, 2008**, or other time fixed by the Court, and serve a copy thereof on the undersigned attorney.

Objections and requests for hearing shall clearly specify the grounds upon which they are based, including the citation of supporting legal authority, if any. General objections will not be considered by the Court.

In the absence of a timely and substantiated objection and request for hearing by an interested party, the Court may grant the Motions without further notice to creditors or other interested parties or hearing thereon.


