**ORDER GRANTING

(a) Motion For Orders: (A) Authorizing and Scheduling an Auction to Solicit Bids for the Sale of Substantially all Assets of Debtor's Bankruptcy Estate, Free and Clear of Liens, Claims, Interests and Encumbrances; (B) Approving Bid and Auction Procedures; (C) Scheduling a Hearing to Consider Approval of the Sale; and (D) Establishing the Form and Manner of Notice;

(b) Motion to Establish Procedures for Determination of Cure Amounts and for Approval of Assumption and Assignment of Executory Contracts and Unexpired Leases Pursuant to an Auction Sale; and

(c) Motion for Limited Authority to Operate Business Pending Auction.

IT IS FURTHER ORDERED that the Trustee is authorized to limit service of the L.B.R. 202 notice of the foregoing motions on the parties identified in the Limit Notice Motion.
