**ORDER ESTABLISHING PROCEDURE FOR  
DETERMINATION OF CURE AMOUNTS AND/OR OBJECTIONS TO THE  
PROPOSED ASSUMPTION AND ASSIGNMENT OF EXECUTORY CONTRACTS AND  
UNEXPIRED LEASES**

THIS MATTER is before the Court on the Motion to Establish Procedures for Determination of Cure Amounts and for Approval of Assumption and Assignment of Executory Contracts and Unexpired Leases Pursuant to an Auction Sale (the "Motion"), filed by Jeffrey A. Weinman, as Chapter 7 Trustee of the Adam Aircraft Industries, Inc. bankruptcy estate (the "Trustee"). The Court held a hearing on the Motion on March 11, 2008, has reviewed the file and is otherwise advised. It is hereby

ORDERED that the Trustee's Motion is GRANTED;

IT IS FURTHER ORDERED that the Trustee shall, no later than **March 14, 2007**, serve via facsimile, email and U.S. Mail: (a) this Order; and (b) a notice to parties to the Debtor's executory contracts and unexpired leases with a conspicuous statement of what the Trustee believes to be the monetary cure amount that the non-debtor party is due under its executory contract and/or unexpired lease (the "Cure Notice"), and shall file a certificate of service reflecting such service;

IT IS FURTHER ORDERED that any party in interest objecting to the amount stated in the Trustee's Cure Notice shall file its objection **no later than fourteen (14) calendar days** after the Trustee's service of this Order and Cure Notice, failing which the Trustee's statement as to the cure amount in the Cure Notice will be conclusive and binding, except as otherwise ordered by the Court for cause shown and under extenuating circumstances;

IT IS FURTHER ORDERED that a hearing on any unresolved objections to the Trustee's Cure Notice and/or the proposed assumption and assignment of executory contracts and unexpired leases is set contemporaneously with approval of the final Sale Motion, for **April 9, 2008, at 10:00 a.m. in Courtroom D**, United States Bankruptcy Court, 721 19<sup>th</sup> Street, Denver, Colorado.
